## PARENTAL CONSENT FORM

We further understand that our child may be working with or near dangers such as ladders, lead-based paint, and/or power tools. We trust that WARM will take appropriate safety precautions and we have emphasized to our child the importance of abiding by them.

We further expressly authorize and consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment, and/or hospital care under the general or special supervision, and on the advice of, licensed physician, surgeon, anesthesiologist, dentist or other qualified medical personnel acting under their supervision, for our child, should the same become necessary because of illness or injury.

We give permission for photographs, videos, or other audio-visual representations of our child to be used by WARM in print, on websites or other media. I further release WARM from any liability associated with promotional use of these images. We release any claim to said images and acknowledge that they are the sole property of and are copyrighted by WARM.

Now therefore, in consideration of the permission extended to our child to accompany the mission team and participate in the mission trip, we do hereby for ourselves, our child, our heirs, executors and administrators, remise, release, and forever discharge Wilmington Area Rebuilding Ministry, its officers, staff, volunteers, as well as all other participants and sponsors of said mission trip, acting officially or otherwise, from all claims, demands, actions or causes of action of any kind including the death of our child or any injury to our child or loss or damage to property which may occur from any cause during the trip as well as all ground and flight travel incident to such trip. It is our intention by this document to consent to our child's participation in the mission trip, to consent

**Volunteer COVID-19 Agreement & Assumption of Risk**

We/I hereby acknowledge that WARM is taking all precautions to protect the public as well as my child as a volunteer. To this extent, I agree to follow Center of Disease Control (CDC), local health district guidelines, and WARM policies and procedures to reduce the spread of COVID-19.

I agree that my child will utilize a surgical mask or other face cover. WARM will provide a face cover if necessary. I agree that my child will wash or sanitize their hands at regular intervals and after using the restroom, sneezing and coughing, and before eating meals. I agree that my child will maintain six (6) feet of distance between themselves, fellow volunteers, WARM staff, and WARM homeowners as much as possible.

I attest that:

- My child will not attend the mission trip if experiencing any symptoms of illness such as a fever, cough, or shortness of breath.
- My child will not travel to a COVID-19 hotspot in the 14 days prior to the mission trip
- I do not believe that my child has been exposed to a person with a confirmed or suspected case of COVID-19
- My child has not been diagnosed with COVID-19 and not yet cleared as non-contagious by state or local public health authorities
- My child is following recommended guidelines as much as possible – practicing social distancing by participating in group activities of fewer than 10, trying to maintain separation of six feet from others, and otherwise limiting their exposure to the coronavirus.

I acknowledge that my child has voluntarily applied to Wilmington Area Rebuilding Ministry’s volunteer program. I understand that there is no direct medical health coverage afforded to me or my child during our relationship with WARM. WARM is not responsible for any potential exposure to COVID-19.

By signing below, I agree to comply with the written instructions above. Failure to comply with these written instructions may result in my child’s volunteer privileges being removed and they may be asked to leave the premises.
